

# CASE OF THE MONTH



## PSEUDO-CANCER

The parents of a two year old child noticed a white glow in one eye in a photograph. The concerned parents took the child to their pediatrician who referred them to a pediatric ophthalmologist whose diagnosis was a cancerous tumor.

The parents opted for a second opinion when they discovered that only 10% of this doctor's practice were children. They turned to *The Children's Eye Center* where 100% of the patients are children and asked Dr. Violeta Radenovich to examine their child.

Following a thorough examination, Dr. Radenovich found that this was a rare congenital, nonhereditary eye disorder commonly called **Coats' Disease**. Also known as exudative retinitis or retinal telangiectasis, the condition is characterized by abnormal develop-ment of blood vessels behind the retina. A treatment program was immediately implemented.

The Children's Eye Center receives many referrals of children with orbital and ocular tumors for accurate diagnosis and treatment.

**Originally from Lima, Peru,** Dr. Radenovich earned her undergraduate and medical school degrees at the Universidad Peruana Cayetano Heredia, Lima, Peru from 1979 to 1987. Her residency (General Ophthalmology) was completed at the University of Texas at Houston Program Hermann Eye Center in 1995. Dr. Radenovich's Fellowship Training in General Pediatric Ophthalmology and ROP/Genetics was completed at the University of Texas Health Science Center at Houston in 1996.

**The Children's Eye Center of El Paso** was founded by Dr. Radenovich in 1996. That same year she received the academic appointment of, "Clinical Assistant Professor, Department of Pediatrics, Texas Tech University Health Sciences Center School of Medicine, El Paso, Texas." Dr. Radenovich maintains this academic appointment to the present day.

**Certified by the American Board of Ophthalmology** in 1998 and re-certified in 2006, Dr. Radenovich is licensed to practice in Pennsylvania, New Mexico, and Texas. Dr. Radenovich is the only female Fellowship trained, Board Certified Pediatric Ophthalmologist in El Paso.
